6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this SDS. Isolate the hazard area and keep unnecessary and unprotected personnel from entering. In case of spill on floor or paved surfaces, mop up and remove to chemical waste storage area until proper disposal can be made if product cannot be used according to label.
